5. FORM OF REQUEST

A requester must comply with all the procedural requirements contained in PAIA relating to the request for access to a record.

A request for access to records held by ET Group in terms of section 50 of PAIA must be made on the form contained in the Regulations Regarding the Promotion of Access to Information (Form C). A copy of the form is attached as Appendix B. The request must be made to ET Group at the address or email address, specified in Section 1 above.

A requester must provide sufficient detail on the prescribed form to allow ET Group to identify the record or records which have been requested and the identity of the requester. If a request is made on behalf of another person or entity, the requester must submit details and proof of the capacity in which the requester is making the request, which must be reasonably satisfactory to ET Group. The requester is also required to indicate the form of access to the relevant records that is required, and to provide his, her or its contact details in the Republic of South Africa.

The requester must identify the right that he, she or it is seeking to exercise by accessing records held by ET Group and must explain why the particular record or records requested is or are required for the exercise or protection of that right.

6. PRESCRIBED FEES

Depending on your request, we may be entitled to charge you certain fees. The fees

which may be payable are prescribed and available either on the Information Regulator

website or the website of the South Africa Human Rights Commission. Before attending

to your request we will advise you of the total fees you will need to pay.
